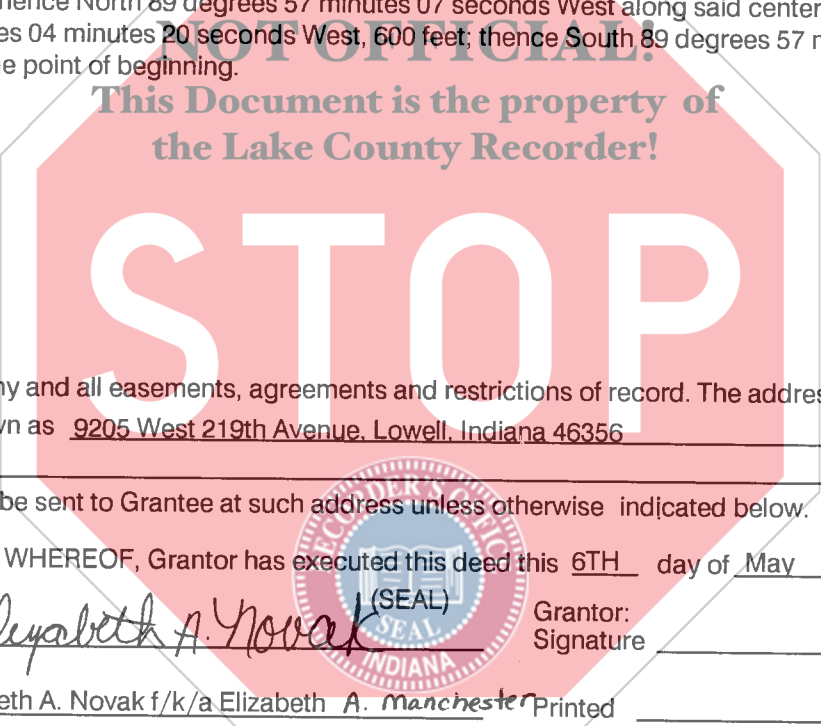
THIS INDENTURE WITNESSETH, That Elizabeth A. Novak f/k/a Elizabeth A. Manchester
