Subject to all taxes, mortgages, covenants, limitations, easements and restrictions of record, if any.

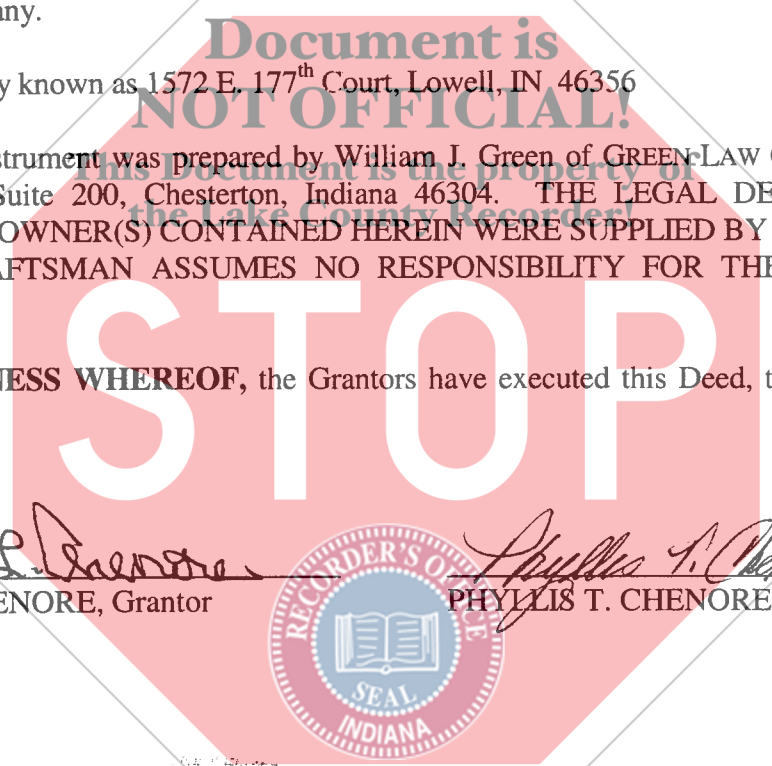

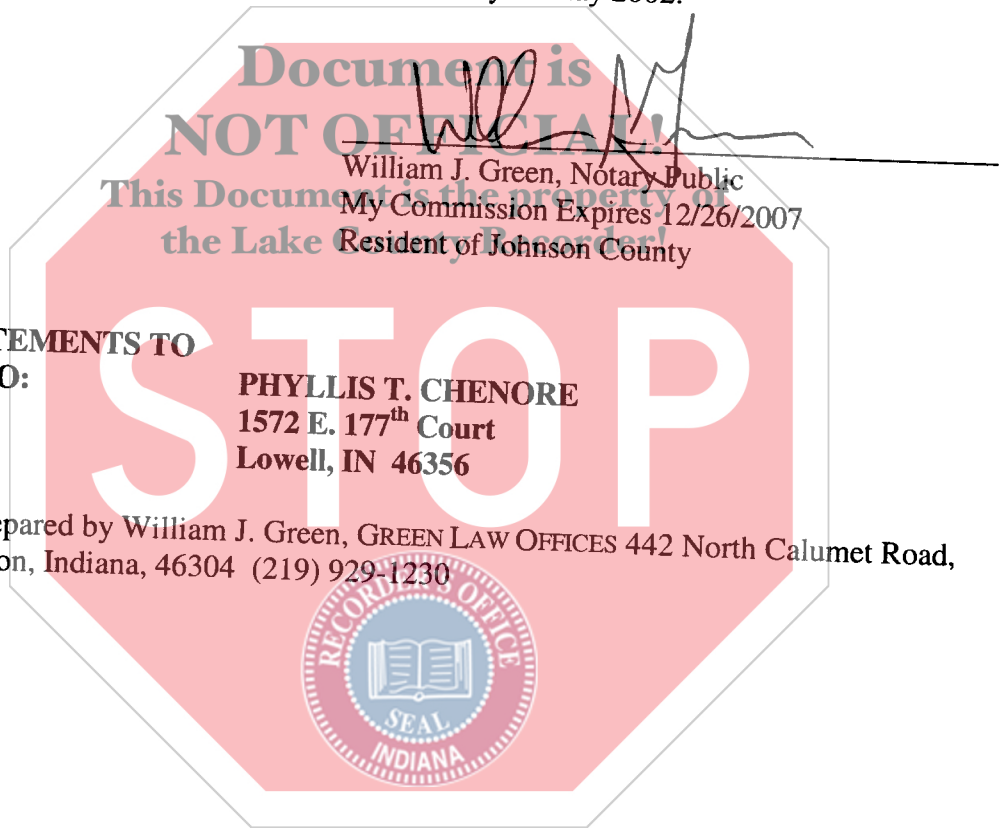
