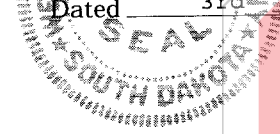
That we, Feldco Factory To You Home Products, LLC

This bond may be terminated at any time by the Surety upon sending notice in writing, by certified mail,
to the Clerk of the Political Subdivision with whom this bond is filed and to the Principal, addressed to them
at the Political Subdivision named herein, and at the expiration of thirty-five (35) days from the mailing of
said notice, this bond shall ipso facto terminate and the Surety shall thereupon be relieved from any liability
for any acts or omissions of the Principal subsequent to said date.

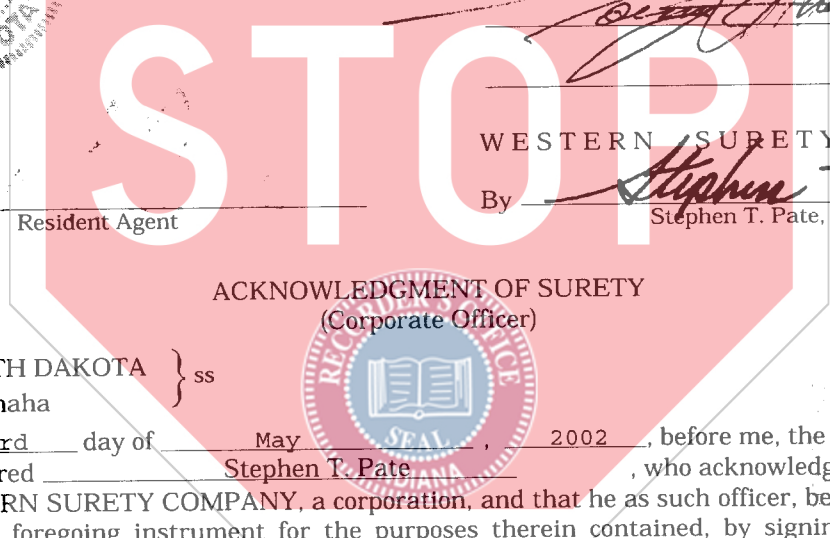

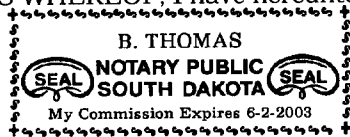
