Parcel 2: The North 132 feet by parallel lines of the Northeast Quarter of the Southeast Quarter and the East Half of the East Half of the Northwest Quarter of the Southeast Quarter of Section 20, Township 33 North, Range 8 West of the 2nd P.M.T. containing 5 acres more or less, in Lake County, Indiana



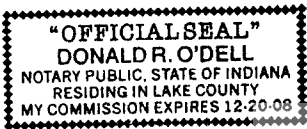
