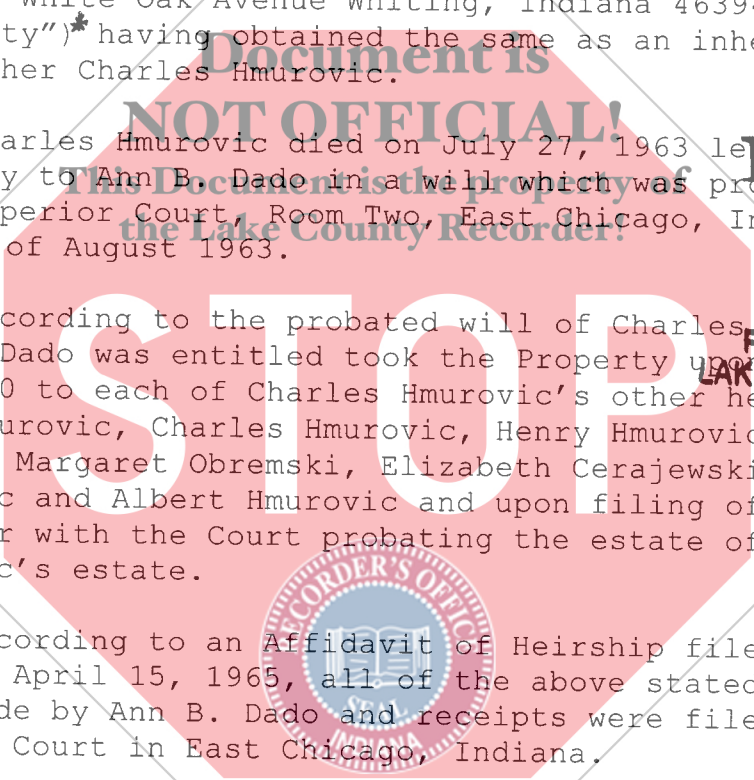

AFFIDAVIT OF HEIRSHIP

Comes now Barbara J. Lowe of 1606 Lake Avenue in Hammond
(Whiting P.O.) Indiana 46394 and states as follows,

1. That she is an adult surviving daughter of her mother Ann B. Dado who died on November 25, 1989. (See attached Exhibit)
2. That Ann B. Dado was the owner of certain property located at 2729 White Oak Avenue Whiting, Indiana 46394 (the "Property")* having obtained the same as an inheritance from her father Charles Hmurovic.
3. That Charles Hmurovic died on July 27, 1963 leaving the Property to Ann B. Dado in a will which was probated in the Lake Superior Court, Room Two, East Chicago, Indiana on the 7th day of August 1963.
4. That according to the probated will of Charles Hmurovic Ann B. Dado was entitled to take the Property upon the death of Charles Hmurovic to each of Charles Hmurovic's other heirs to wit: John Hmurovic, Charles Hmurovic, Henry Hmurovic, Helen Rogina, Margaret Obremski, Elizabeth Cerajewski, Joseph Hmurovic and Albert Hmurovic and upon filing of receipts therefor with the Court probating the estate of Charles Hmurovic's estate.
5. That according to an Affidavit of Heirship filed by Ann B. Dado on April 15, 1965, all of the above stated payments were made by Ann B. Dado and receipts were filed with the Probate Court in East Chicago, Indiana.

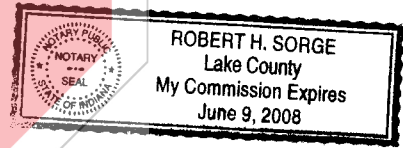
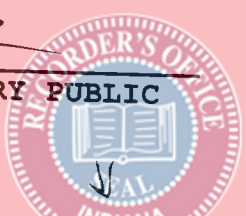
