3. The work and labor were done and the materials and machinery were furnished by the undersigned within the last sixty days.



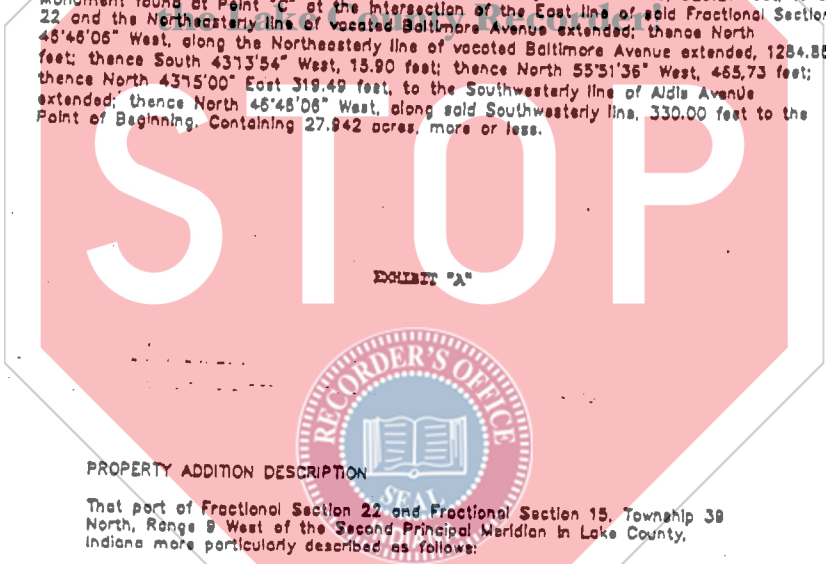
