# TAX TITLE DEED TO COUNTY

Whereas the Lake County Board of Commissioners did the 21st day of May, 2002 produced to the County of Lake, in the State of Indiana, a certificate of sale dated the 9/27/2001, signed by PETER BENJAMIN who, at the date of sale, was Auditor of the County, from which it appears that said County on the 9/27/2001, obtained, pursuant to law, the real property described in this indenture for the sum of SIX HUNDRED SEVENTY AND 64/100 DOLLARS (\$670.64) being the amount due on the following tracts of land returned delinquent in the name WARE, DAVID KEVIN for 2000 and prior years, namely:

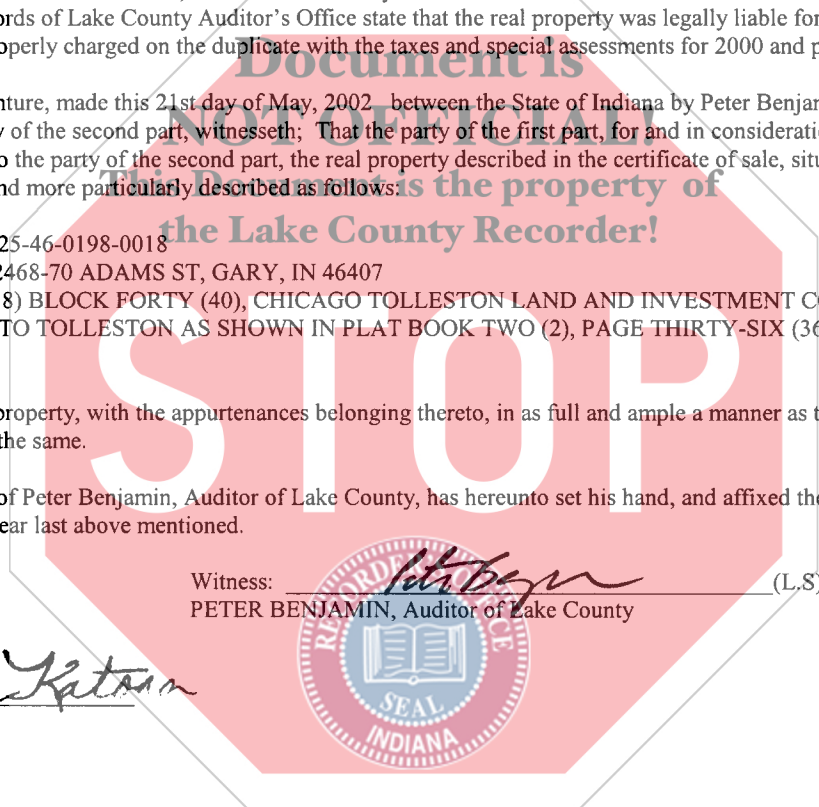




