Subject to easements of highways, streets, alleys, sewers, tiles, drains, and public utilities.

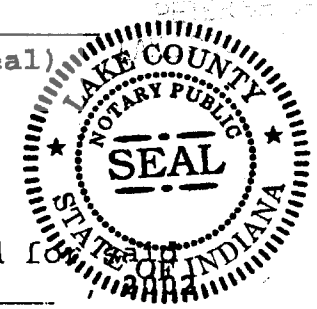
