PARTIAL RELEASE OF MORTGAGE

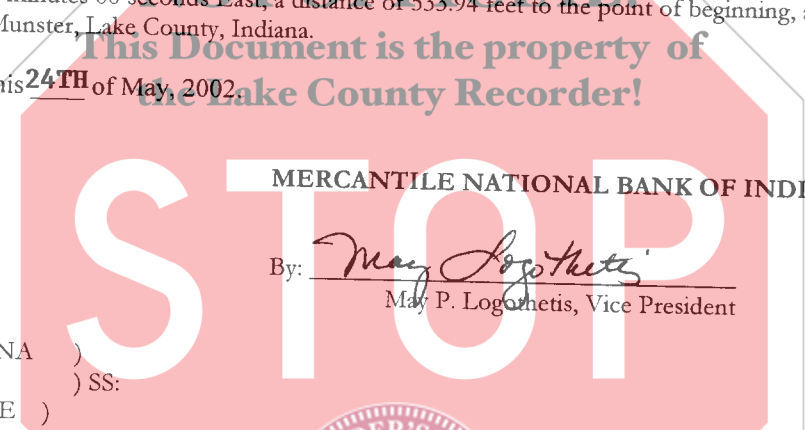

The North 204.28 feet, by parallel lines, of the following described parcel: part of Fractional Section 36, Township 36 North, Range 10 West of the Second Principal Meridian in the Town of Munster, Lake County, Indiana, being more particularly described as follows: Commencing at the Southeasterlymost corner of West Lakes Addition, Phase One, to the Town of Munster, as recorded in Plat Book 82, page 18 in the Office of the Recorder of Lake County, Indiana: thence South 00 degrees 09 minutes 15 seconds East, along the West Right-of-Way line of the Louisville and Nashville Railroad (50 feet wide), a distance of 353.89 feet, to the point of beginning; thence continuing South 00 degrees 09 minutes 15 seconds East, along said West Right-of-Way line, a distance of 1016.09 feet; thence South 89 degrees 42 minutes 30 seconds West, a distance of 705.97 feet; thence Northwest, along a curve, concave to the Southwest, having a radius of, 550.00 feet, an arc distance of 300.64 feet (the chord of which bears North 24 degrees 20 minutes 26 seconds West, a chord distance of 296.91 feet); thence North 40 degrees 00 minutes 00 seconds West; a distance of 201 feet; thence North 50 degrees 00 minutes 00 seconds East, a distance of 190.59 feet, to a point of curve; thence Easterly, along said curve concave to the South, having a radius of 200.00 feet, an arc distance of 139.63 feet (the chord of which bears North 70 degrees 00 minutes 00 seconds East, a chord of 136.81 feet); thence North 90 degrees 00 minutes 00 seconds East, a distance of 54.64 feet; thence North 00 degrees 00 minutes 00 seconds West, a distance of 534.66 feet; thence North 90 degrees 00 minutes 00 seconds East, a distance of 533.94 feet to the point of beginning, all in the Town of Munster, Lake County, Indiana.
