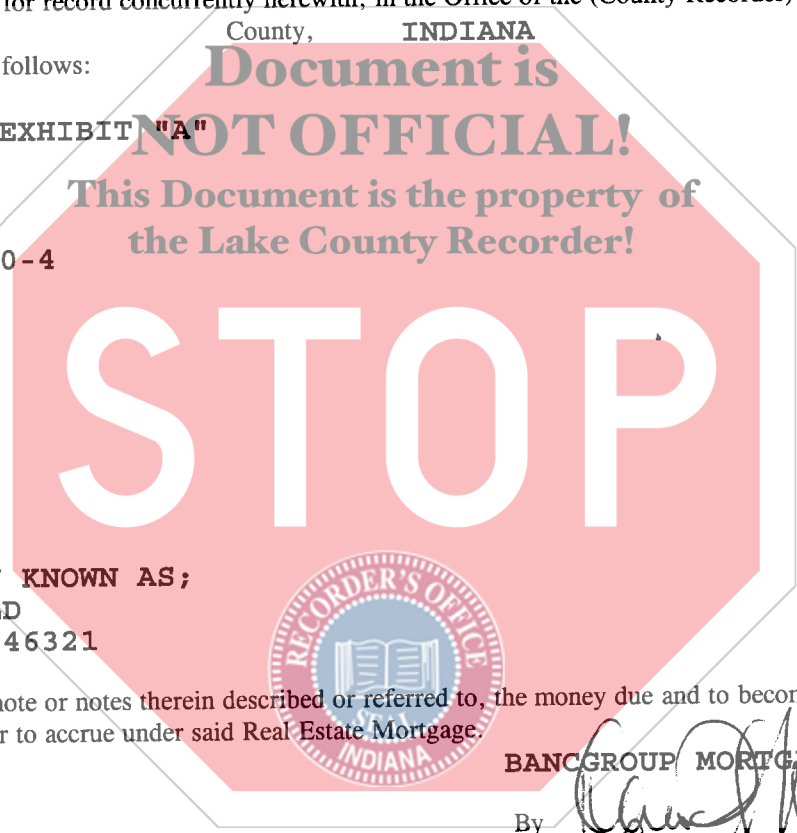

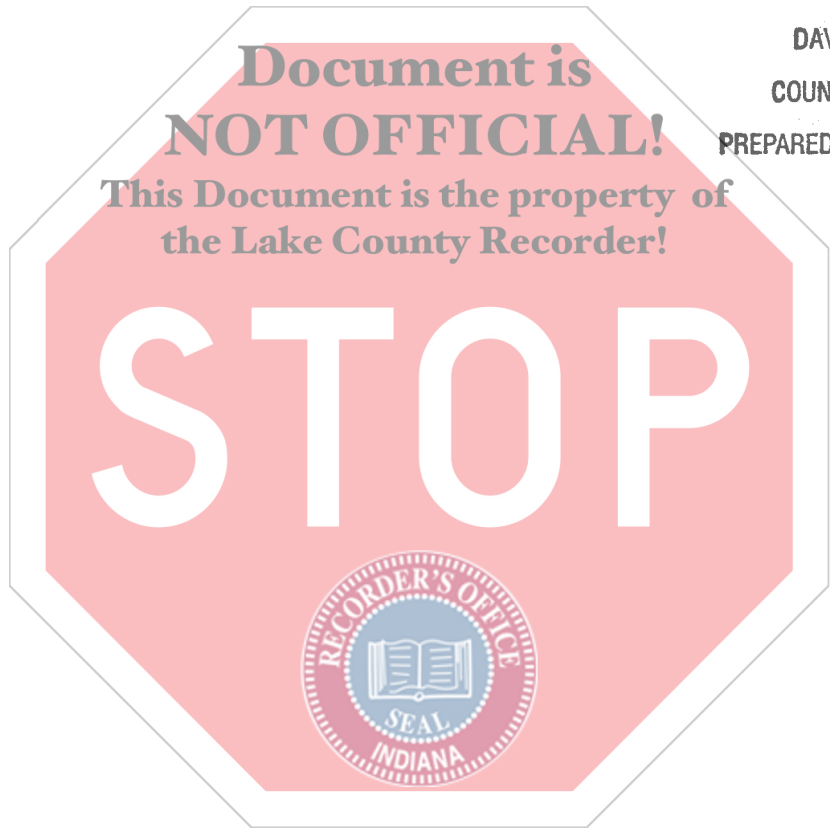

LEGAL DESCRIPTION

Part of Lot 20, The Townhomes at White Oak Estates, Block 7 to the Town of Munster, Lake County, Indiana as recorded in Plat Book 86 page 67 in the Office of the Recorder of Lake County, Indiana, more particularly described as follows: Beginning at the Southeast corner of said Lot 20; thence North 88 degrees 47 minutes 30 seconds West, along the Southerly line of Lot 20, said line also being the Northerly Right-of-Way line of Main Street, a distance of 119.02 feet to the Southwest corner of said Lot 20; thence North 00 degrees 00 minutes 00 seconds East, along the Westerly line of Lot 20, a distance of 106.75 feet, to a point of deflection in the Westerly line of Lot 20, thence continuing on said Westerly line of Lot 20, North 18 degrees 15 minutes 49 seconds West, a distance of 14.81 feet; thence South 85 degrees 14 minutes 12 seconds East, a distance of 125.12 feet to the Easterly line of Lot 20; thence South 00 degrees 31 minutes 56 seconds West, along the Easterly line of Lot 20, a distance of 112.94 feet to the place of beginning, all in the Town of Munster, Lake County, Indiana.
