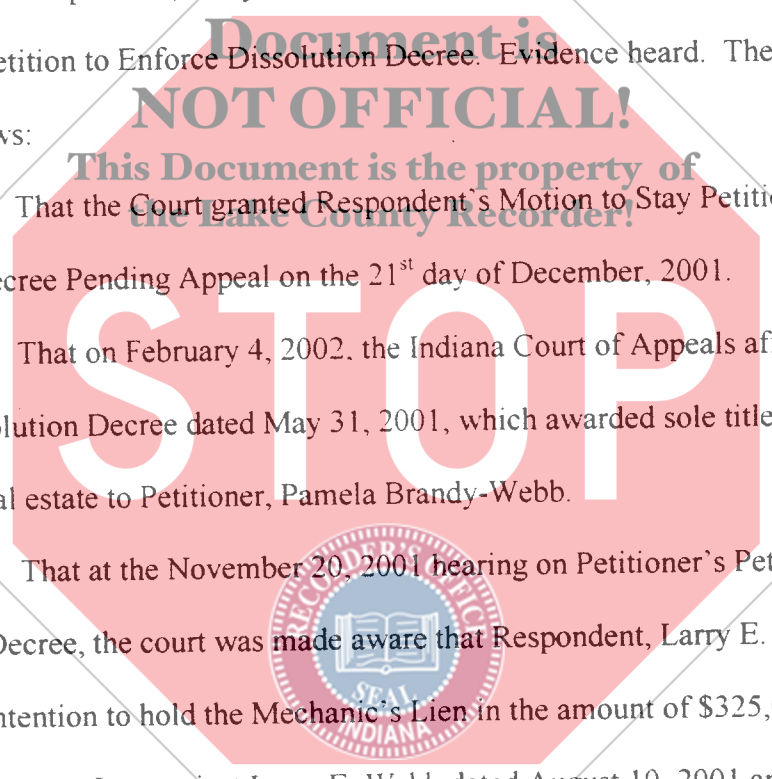

**ORDER TO ENFORCE DISSOLUTION DECREE  
 DATED MAY 31, 2001**

Comes now the Petitioner, Pamela Brandy-Webb, by counsel, Laura J. Wyatt and comes now the Respondent, Larry Webb, by counsel, Bessie M. Taylor. Submitted on Petitioner's Petition to Enforce Dissolution Decree. Evidence heard. The Court now finds as follows:

1. That the Court granted Respondent's Motion to Stay Petitioner's Petition to Enforce Decree Pending Appeal on the 21<sup>st</sup> day of December, 2001.
2. That on February 4, 2002, the Indiana Court of Appeals affirmed the Trial Court's Dissolution Decree dated May 31, 2001, which awarded sole title of the residential real estate to Petitioner, Pamela Brandy-Webb.
3. That at the November 20, 2001 hearing on Petitioner's Petition to Enforce Dissolution Decree, the court was made aware that Respondent, Larry E. Webb had filed a Notice of Intention to hold the Mechanic's Lien in the amount of \$325,000.00 filed by LEW Management, Inc. against Larry E. Webb dated August 10, 2001 and recorded August 10, 2001 as document no. 2001064152.

4. That Respondent Larry E. Webb and Larry E. Webb doing business as LEW Management, Inc. have been duly notified of these proceedings.

**IT IS THEREFORE ORDERED, ADJUDGED, and DECREED** by the court as follows:

1. That Petitioner, Pamela Brandy-Webb is awarded sole rights, title and interest of the residential real estate and Respondent, Larry E. Webb is divested of any and all interest in said residential property as of the date of the Dissolution Decree.
