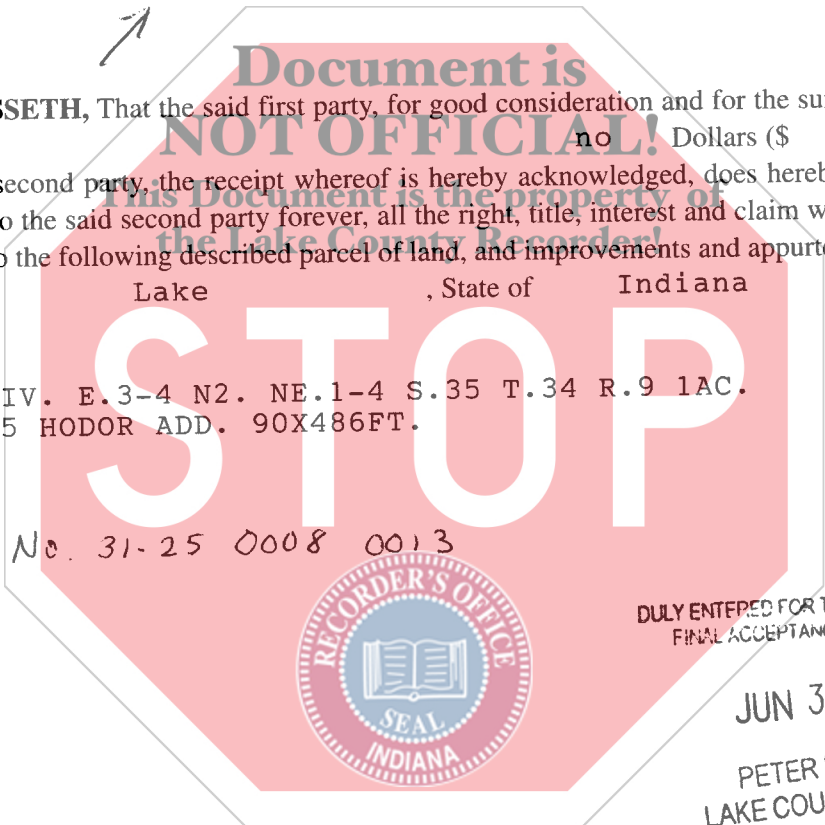
QUITCLAIM DEED
