

QUITCLAIM DEED

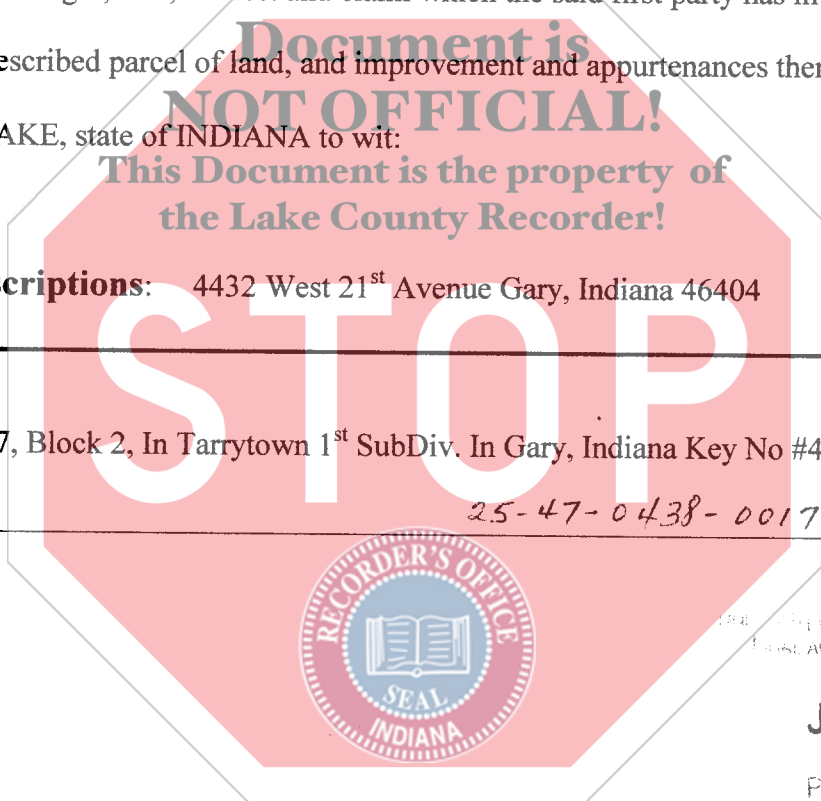
THIS QUIT CLAIM DEED, executed this 12th day of DECEMBER, 1998
