LEGAL DESCRIPTION

That part of Lots 39 and 40 in Block 3 of Plum Creek Village 5th Addition to the Town of Schererville, as per plat thereof, recorded in Plat Book 62 page 43, in the Office of the Recorder of Lake County, Indiana, being more particularly described as follows: Commencing at the Westerly most corner of said Lot 39; thence South 44 degrees 05 minutes 03 seconds East, along the Southwesterly line of said Lot 39, a distance of 43.40 feet to the place of beginning; thence continuing South 44 degrees 05 minutes 03 seconds East, along said Southwesterly line of Lot 39, a distance of 28.0 feet; thence North 45 degrees 54 minutes 57 seconds East, parallel with the Northwesterly line of said Lot 39, a distance of 157.54 feet to a point on the curved Westerly line of Holly Lane (60 feet wide) lying 37.12 feet Southeasterly of the point of curve in said Westerly line of Holly Lane; thence Northwesterly along said Holly Lane, on a curve concave to the Southwest and having a radius of 280.0 feet, an arc distance of 28.11 feet; thence South 45 degrees 54 minutes 57 seconds West, parallel with the Northwesterly line of said Lot 39, a distance of 159.86 feet to the place of beginning, all in Schererville, Lake County, Indiana.
