AFFIDAVIT OF SURVIVORSHIP

Jacqueline C. Toliver nka Jacqueline C. Ayers, being first duly sworn upon her oath, deposes and says:

1. That she and **Tommie Mack** acquired title to certain Real Estate in **Lake County, Indiana** To- Wit: **Lot No. Eleven (11), and the North ten (No. 10') feet of Lot No. Twelve (12), in Block No. Three (3), as marked and laid down on the recorded plat of Mid-City Realty Company's Central Subdivision, in the City of Gary, Lake County, Indiana, as the same appears of record in Plat Book 15, page 31, in the Recorder's Office of Lake County, Indiana.**

2. That **Tommie Mack** died on 4-17-00, at which time **Jacqueline C. Toliver nka Jacqueline C. Ayers** acquired title as the surviving joint tenant.

3. 4. That all debts, estate and inheritance taxes, funeral expenses, and expenses of the last illness of **Tommie Mack** have been fully paid and satisfied.


5. That the purpose of this affidavit is to induce the **Lake County Auditor** to show the transfer of such property on his/her records.
