Irene Jackim, being sworn upon oath, states and certifies that:

1. I am the duly appointed and acting Co-Trustee to the Jackim Living Trust dated April 19, 1995;
2. The Jackim Living Trust is in existence and is in full force and effect;
3. Stanley Jackim, the other Co-Trustee, died on March 27, 2002;
4. An amendment was made to the Jackim Living Trust on July 21, 1998, but such amendment did not change the status of the initial Co-Trustees, Stanley Jackim and Irene Jackim;

5. At the death of Stanley Jackim, the Jackim Living Trust dated April 19, 1995 was the owner of the following described real estate:

27.5 feet by parallel lines off the entire South side of Lot 31 and 17.5 feet by parallel lines off the entire North side of Lot 30, in Block 2 in Hammond Steel City Addition to Hammond, as per plat thereof, recorded in Plat Book 17 page 18 in the Office of the Recorder of Lake County, Indiana.
