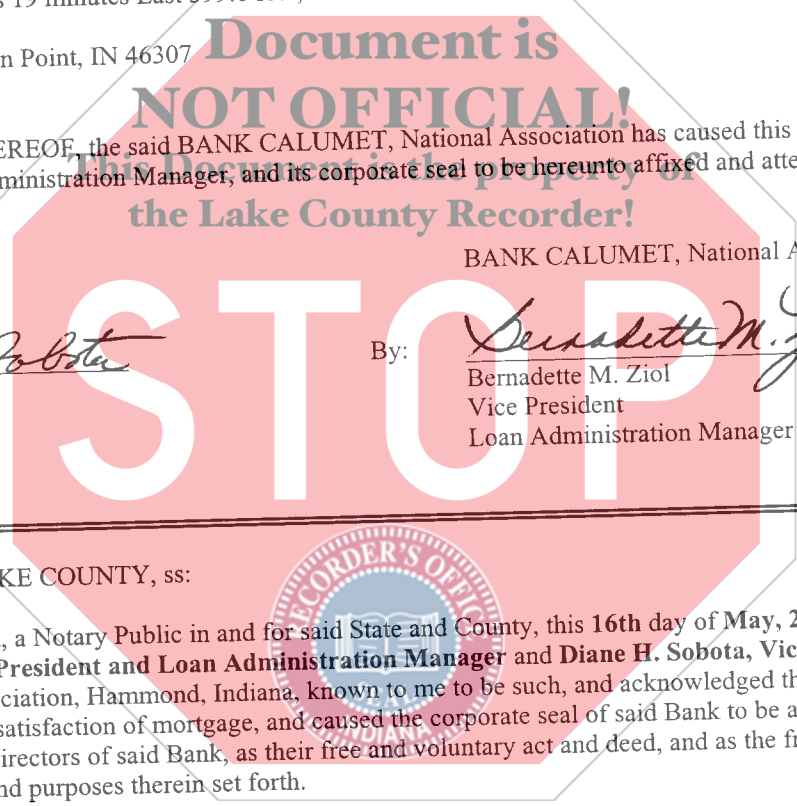
SATISFACTION OF MORTGAGE
