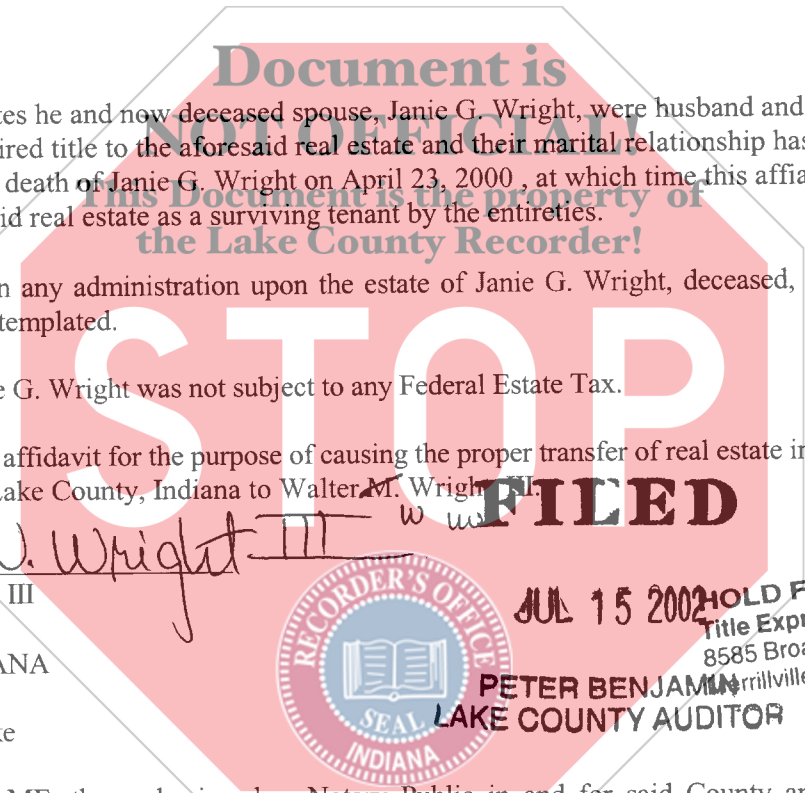
There has not been any administration upon the estate of Janie G. Wright, deceased, nor is any administration contemplated.
