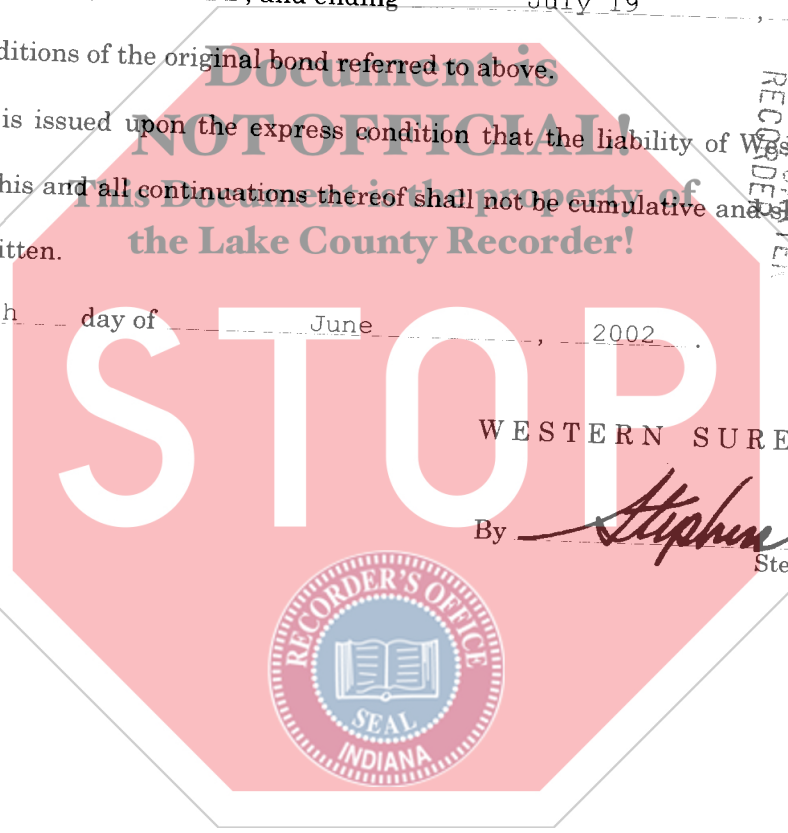

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

Pate of Sioux Falls, South Dakota, its regularly elected President, as Attorney-in-Fact, with full power and authority hereby conferred upon him to sign, execute, acknowledge and deliver for and on its behalf as Surety and as its act and deed, all of the following classes of documents to-wit:
