

**TRUTH AFFIDAVIT**  
IN THE NATURE OF SUPPLEMENTAL  
RULES FOR ADMINISTRATIVE AND MARITIME CLAIMS RULES C(6)

**Rejection of Contract Offer**

In Commerce, everything must be stated in Truth. 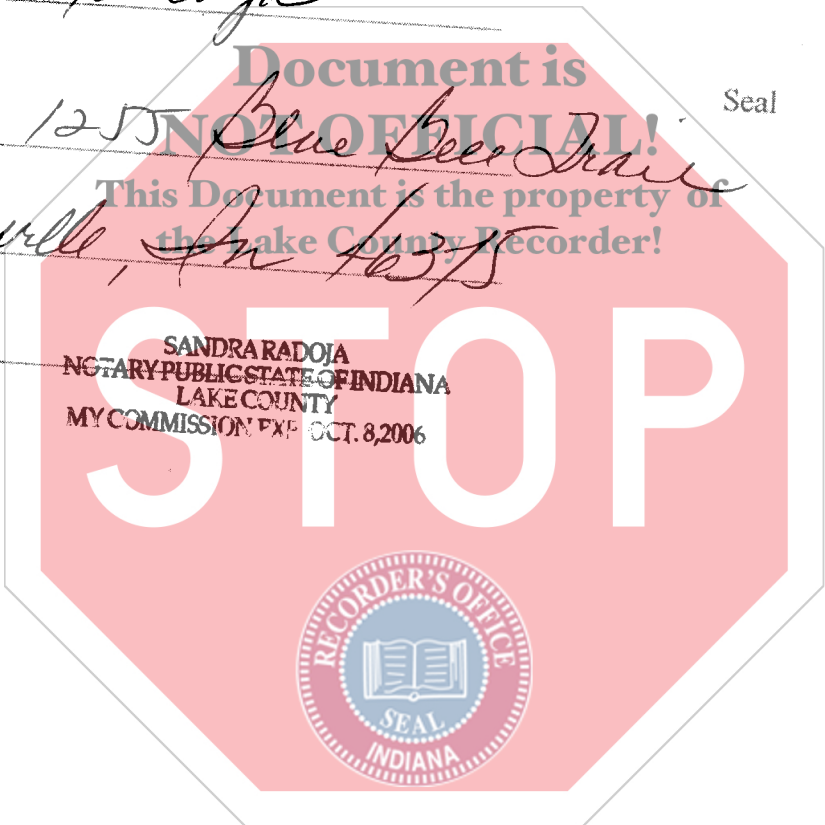
