## Parcel I:

Part of Southwest Quarter (SW  $\frac{1}{4}$ ) of the Northeast Quarter (NE  $\frac{1}{4}$ ) of Section Thirty-two (32) Township Thirty-six (36) North, Range Seven (7) West of the  $2^{nd}$  Principal Meridian, in the City of Hobart, Lake County, Indiana, described as follows:
