AFFIDAVIT OF SURVIVORSHIP

Della Jones, being first duly sworn upon her oath, deposes and says:

1. That she is the wife of **Jesse C. Jones** that they were married on the date that they acquired title as husband and wife as tenants by the entireties to certain Real Estate in **Lake County, Indiana** To- Wit:

Lot 21, Block 8, East End Resubdivision, in Indiana Harbor, in the City of East Chicago, as shown in Plat Book 5, page 36 in Lake County, Indiana.

2. The marital relationship which existed between **Jesse C. Jones** and **Della Jones** continued unbroken from the time they so acquired title to said real estate until the death of **Jesse C. Jones** on **September 23, 2000**, at which time **Della Jones** acquired title as surviving tenant by the entireties.

3. That the gross value of the estate of the said **Jesse C. 5. That the purpose of this affidavit is to induce the **Lake County Auditor** to show the transfer of such property on his records.
