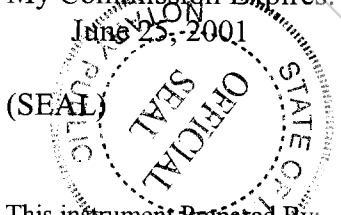

LEGAL DESCRIPTION

That part of the Northeast quarter of Section 32, Township 35 North, Range 7 West of the 2nd P.M., described as: Beginning at a point which is on the North line of said Northeast quarter and 800.00 feet West of the Northeast corner thereof; thence due South parallel with the East line of said Northeast quarter a distance of 1757.92 feet to a point on the Northerly right-of-way line of the Chesapeake and Ohio Railroad Company; thence North 60 degrees 04 minutes 00 seconds West along said right-of-way line a distance of 455.78 feet; thence due North parallel with the East line of said Northeast quarter a distance of 1534.09 feet to a point on the North line of said Northeast quarter; thence South 89 degrees 28 minutes 40 seconds East a distance of 395.0 feet to the place of beginning, all in Lake County, Indiana
