# TAX TITLE DEED TO COUNTY

Whereas the Lake County Board of Commissioners did the 9th day of August, 2000 produced to the County of Lake, in the State of Indiana, a certificate of sale dated the 20<sup>th</sup> day of March, 2000 signed by Peter Benjamin who, at the date of sale, was Auditor of the County, from which it appears that said County on the 20<sup>th</sup> day of March, 2000 obtained, pursuant to law, the real property described in this indenture for the sum of ONE HUNDRED EIGHTY-SEVEN AND 43/100 DOLLARS (\$187.43) being the amount due on the following tracts of land returned delinquent in the name SMI PARTNERSHIP for 1999 and prior years, namely:

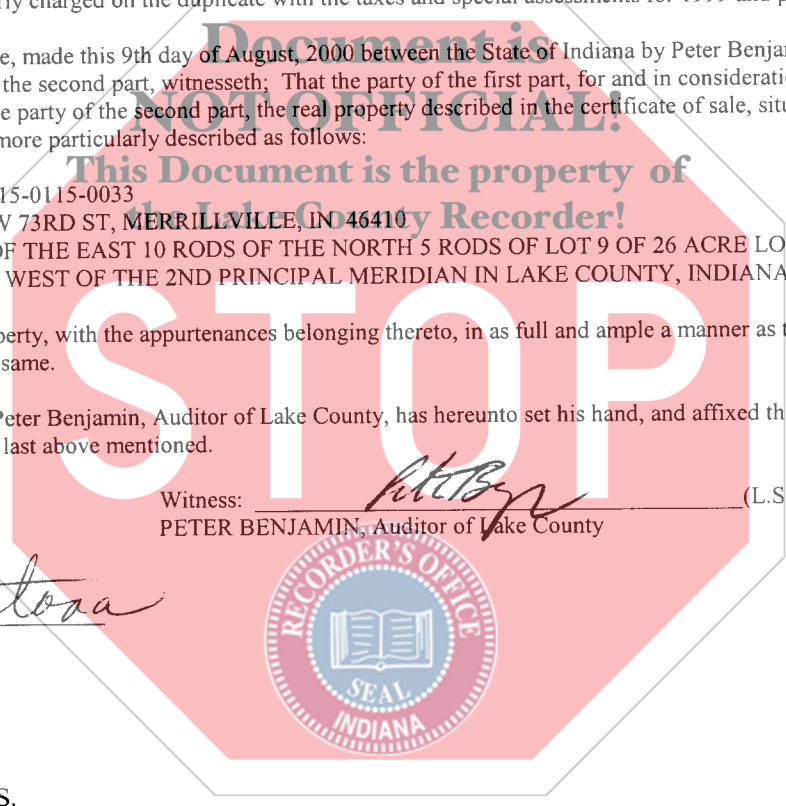
