TAX TITLE DEED TO COUNTY

Whereas the Lake County Board of Commissioners did the 25th day of June, 2002 produced to the County of Lake, in the State of Indiana, a certificate of sale dated the 27th day of September, 2001, signed by PETER BENJAMIN who, at the date of sale, was Auditor of the County, from which it appears that said County on the 27th day of September, 2001, obtained, pursuant to law, the real property described in this indenture for the sum of THIRTEEN THOUSAND, SIXTY-SEVEN AND 98/100 DOLLARS (\$13,067.98) being the amount due on the following tracts of land returned delinquent in the name ARMSTRONG, GLENDA KAYE for 2000 and prior years, namely:

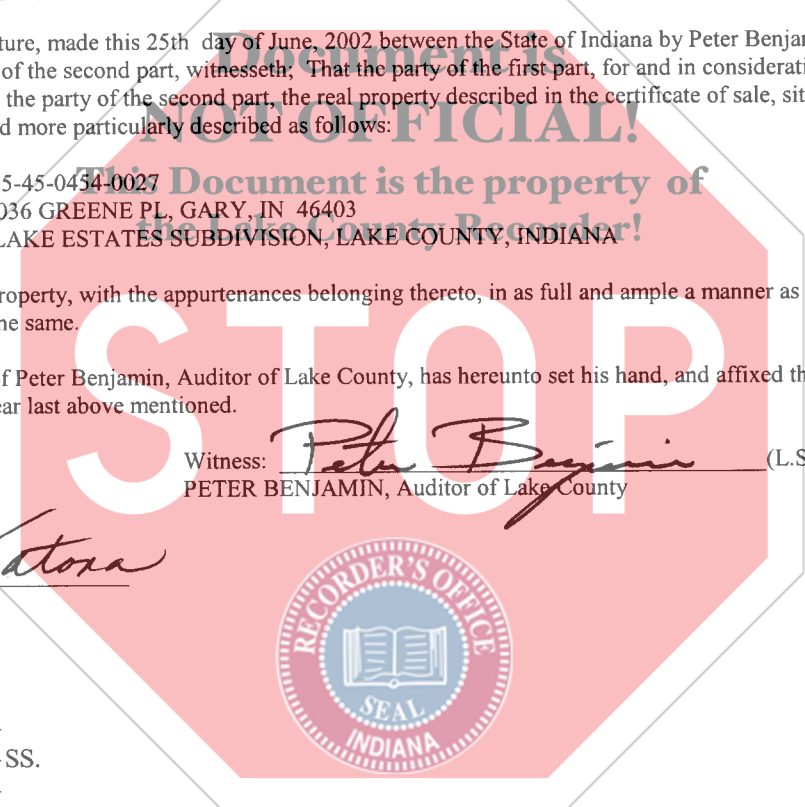
