any damage by reason of his/her engaging in said business.

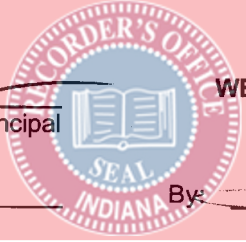
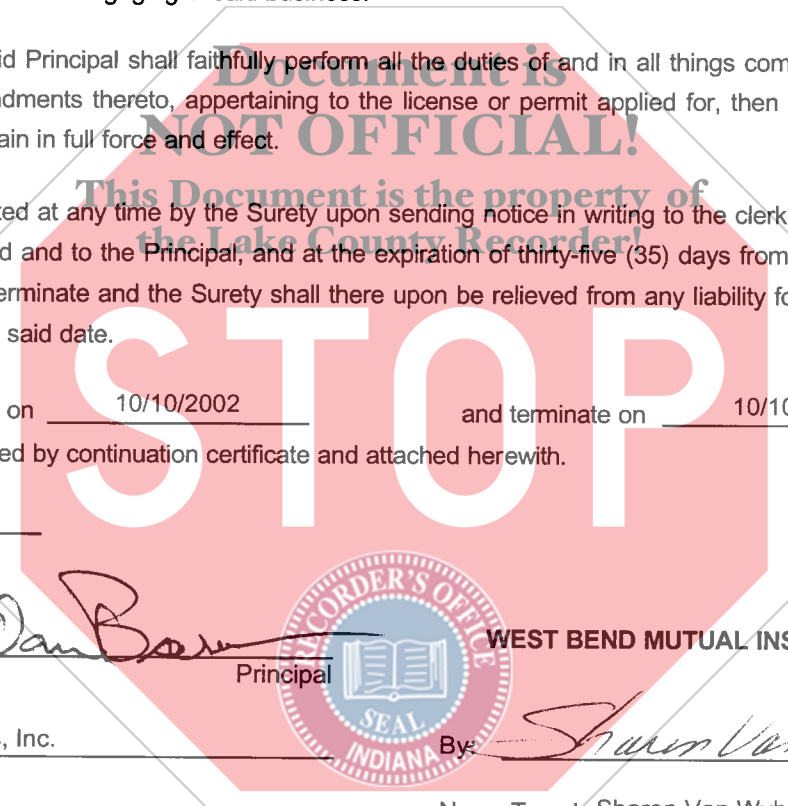
NOW, THEREFORE, if said Principal shall faithfully perform all the duties of and in all things comply with the laws and ordi-

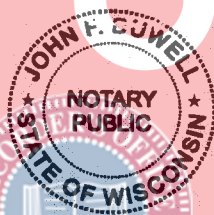
