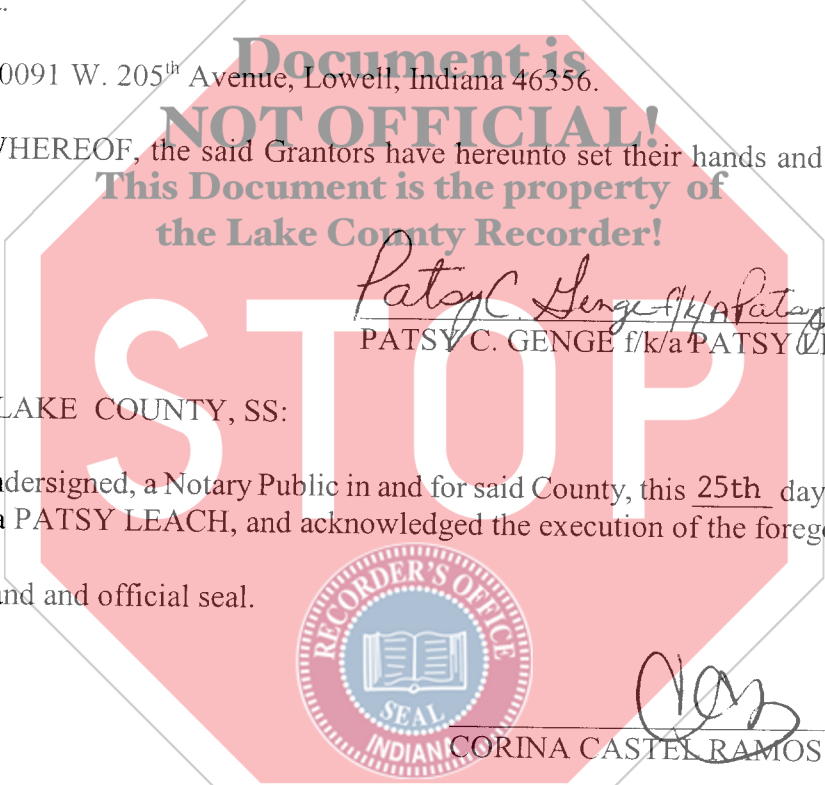
QUIT-CLAIM DEED

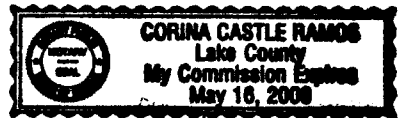
