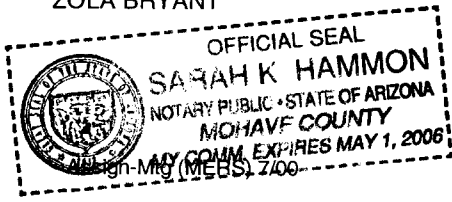


Exhibit A

Part of the south half of the southeast quarter of the northwest quarter of section 4, township 35 north, range 8 west of the second principal meridian, in lake county, Indiana, described as follows: beginning at a point which is 379.24 feet south of the north line and 1042.60 feet east of the west line, thence east 100 feet to a point 377.81 feet south of the north line, thence south 282.35 feet to a point on the south line which is 179.19 feet west of the southeast corner, thence west 100 feet to a point which is 1042.68 feet east of the southwest corner, thence north 281.01 feet to the place of beginning.
