by the said Oblige.

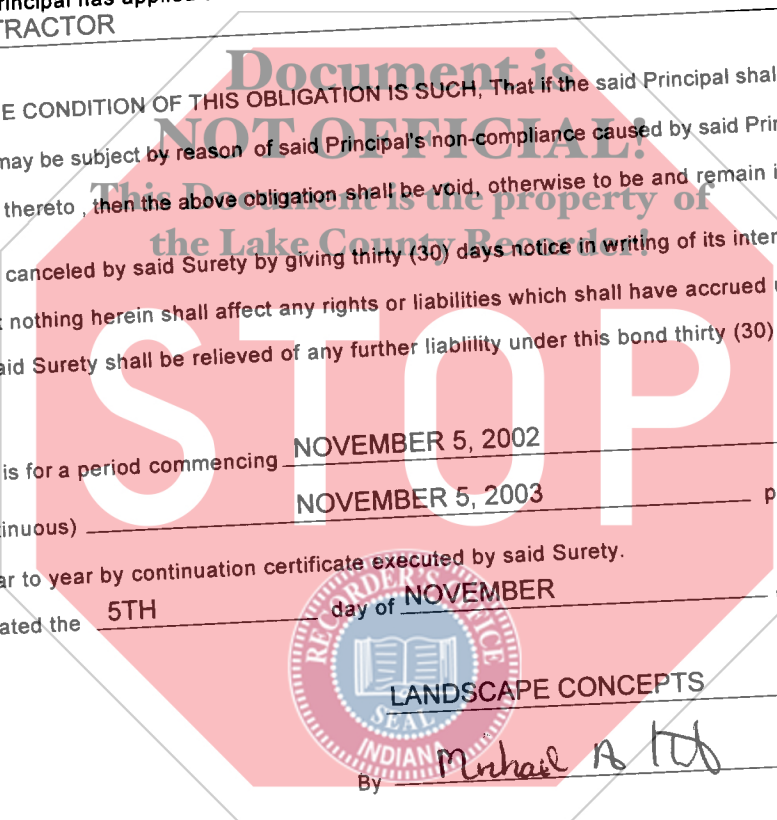
The term of this bond is for a period commencing NOVEMBER 5, 2002

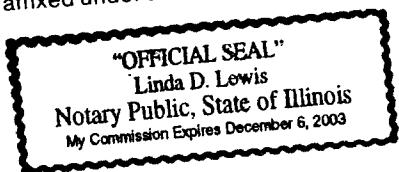

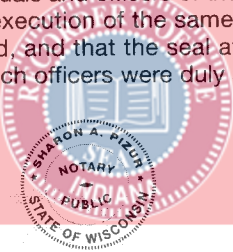
