## MORTGAGE SUBORDINATION AGREEMENT

COMES NOW, NATIONAL CITY, INDIANA, a national banking association with its principal offices located at 101 West Washington Street, Indianapolis, Indiana 46255

## WITNESSETH:

WHEREAS, National City, Indiana has been granted by <u>Reginald Robinson and Betty R.
