**ORDER APPOINTING PERSONAL REPRESENTATIVE FOR
SUPERVISED ADMINISTRATION OF ESTATE AND
DIRECTING ISSUANCE OF LETTERS TESTAMENTARY**

Comes now the Petitioner, Robert S. Songer, and files his Petition for Probate of Will; for Issuance of Letters Testamentary; and for Appointment of Personal Representative for Supervised Administration of Estate. And the Court, in all things being duly advised, now FINDS and ORDERS as follows:

1. That there is now produced in open Court an instrument in writing purporting to be the Last Will and Testament of Eileen Songer, deceased. That, on September 4, 1982, the decedent and the two (2) witnesses to the decedent's will, self-proved said will.
2. That the decedent, Eileen Songer, died on January 27, 2001, and at the time of such death was domiciled at Waynetown, Montgomery County, Indiana.
3. That said written instrument purporting to be the Last Will and Testament of the decedent is hereby admitted to probate and recorded as such.
4. That the decedent's estate is believed to be solvent
5. That the decedent's will calls for the appointment of Lee C. Songer as personal representative of her estate; however, Lee C. Songer has waived his right to serve as personal representative of the decedent's estate; and that the decedent's will provides for Robert S. Songer to be the successor personal representative of the decedent's estate, and for him to serve in such

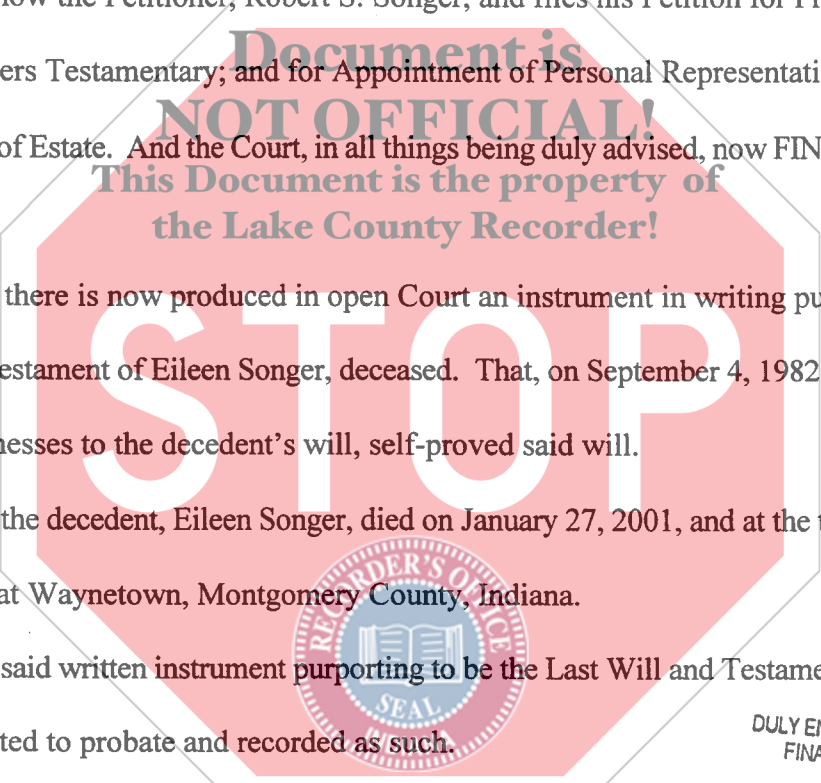

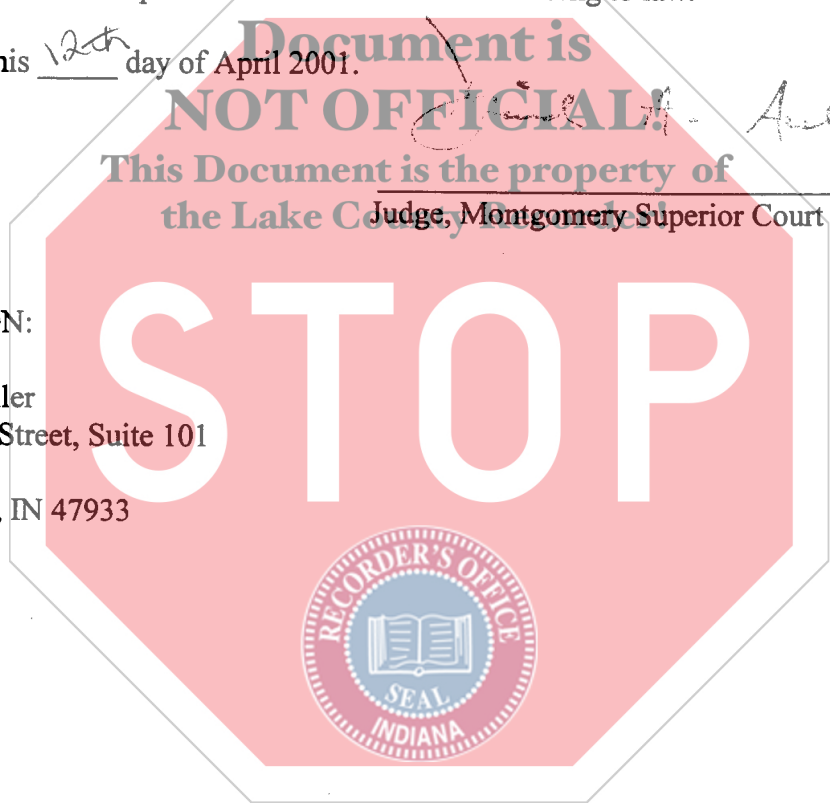
