Subject to the following restrictions:

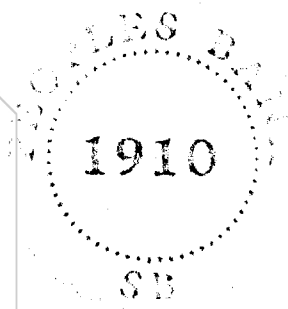
1. All taxes and special assessments for the year 2002 due and payable in 2003 and thereafter;
