Part of the East 1/2 of the Northeast 1/4 of Section 7, Township 35 North, Range 7 West of the Second Principal Meridian, described as follows:

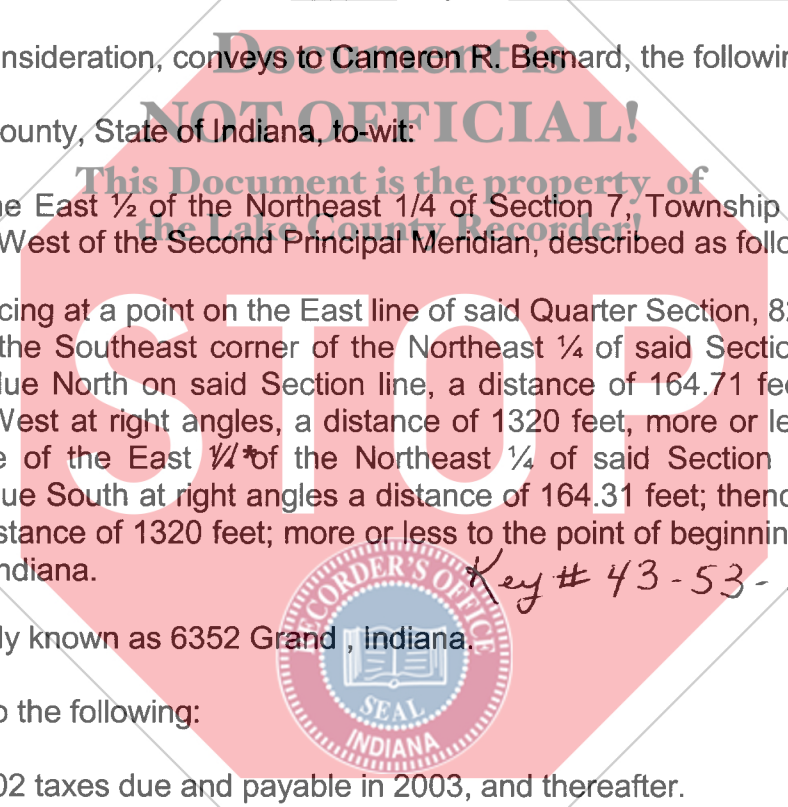




