CERTIFICATION OF PAYMENT OF COURT-APPOINTED APPRAISERS' AWARD AND REQUEST FOR TRANSFER

Steve Carter, Attorney General of Indiana, by Marcia Avery Hanley, Deputy Attorney General, for and on behalf of the State of Indiana, certifies:

1. That the State of Indiana is the Plaintiff in the case titled State of Indiana v. Amoco Oil Company, et al., pending in the Circuit Court of Lake County, as Cause No. 45D04-0205-PL-21. This case is an action in eminent domain in which the State is appropriating the real estate described as:

A part of Lot 1 in Reynolds Addition, an addition to the Town of Highland, Indiana, the plat of which is recorded in Plat Book 41, page 18, in the Office of the Recorder of Lake County, Indiana, described as follows: Beginning at the southwest corner of said lot: thence North 0 degrees 21 minutes 56 seconds West 4.325 meters (14.19 feet) along the west line of said lot; thence South 89 degrees 27 minutes 56 seconds East 23.178 meters (76.04 feet); thence North 51 degrees 18 minutes 49 seconds East 22.609 meters (74.18 feet); thence North 4 degrees 49 minutes 53 seconds East 5.523 meters (18.12 feet); thence North 0 degrees 21 minutes 47 seconds West 32.556 meters (106.81 feet) to the north line of said lot; thence South 89 degrees 29 minutes 36 seconds East 1.257 meters (4.12 feet) along said north line to the northeast corner of said lot; thence South 0 degrees 21 minutes 56 seconds East 53.628 meters (175.94 feet) (176.01 feet by said addition plat) along the east line of said lot to the southeastern line of said lot; thence South 45 degrees 04 minutes 34 seconds West 4.277 meters (14.03 feet) along said southeastern line to the south line of said lot; thence North 89 degrees 28 minutes 56 seconds West 39.629 meters (130.02 feet) along said south line to the point of beginning and containing 380.9 square meters (4,100 square feet), more or less.

2. That on November 12, 2002, the court-appointed appraisers returned a report to the Court reporting total damages in the amount of Three Hundred Seven Thousand Nine Hundred Fifty Dollars (\$307,950.00), which amount was paid to the Clerk of this Court, by the Plaintiff, on December 5, 2002.

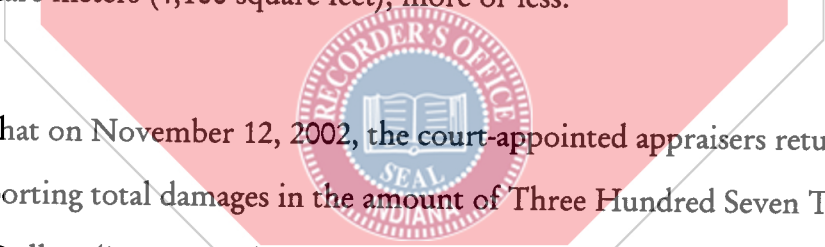
