All other terms and conditions of the mortgage shall remain in full force and effect.

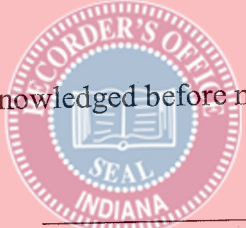

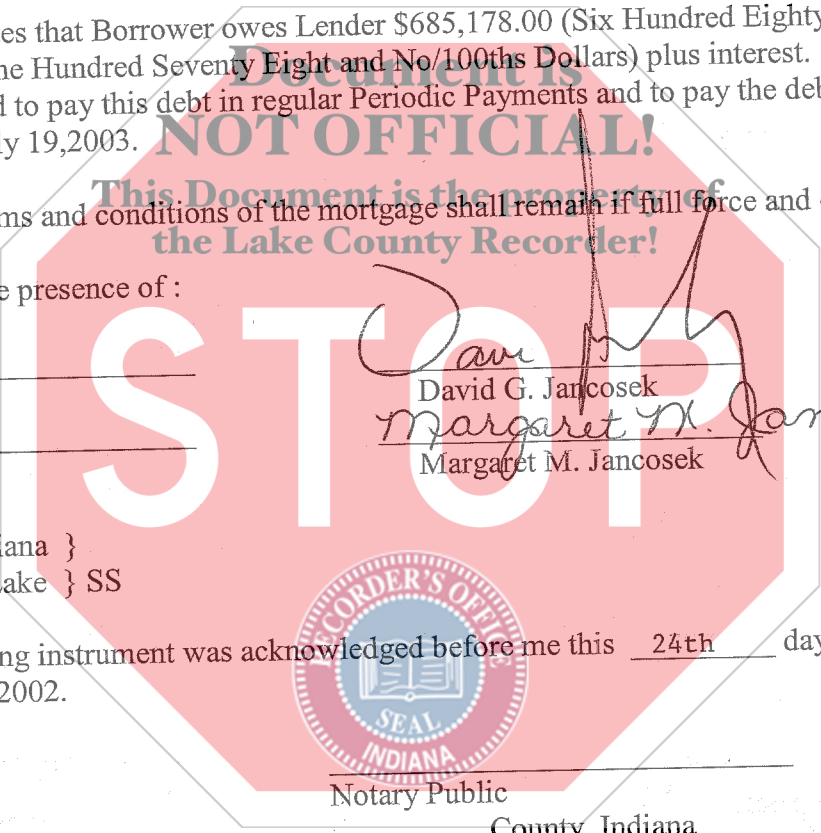

LEGAL DESCRIPTION

PARCEL I: Lot 50 in Ellendale Farm Unit One, in the City of Crown Point, as per plat thereof, recorded in Plat Book 82 page 40, in the Office of the Recorder of Lake County, Indiana.

PARCEL II: That part of Outlot "A", in Ellendale Farm, Unit One, in the City of Crown Point, as per plat thereof, recorded in Plat Book 82 page 40, in the Office of the Recorder of Lake County, Indiana, described as follows: Beginning at the Southwestern corner of Lot 50, in Ellendale Farm Unit One; thence Northwesterly, a distance of 140 feet, along the West line of Lot 50, to the Northwestern corner of Lot 50; thence Southwesterly along the Northern line of Outlot "A", a distance of 30 feet; thence 90 degrees Southeasterly, a distance of 140 feet; thence Northeasterly to the point of beginning.

PARCEL III: That part of Outlot "A", in Ellendale Farm, Unit One, in the City of Crown Point, as per plat thereof, recorded in Plat Book 82 page 40, in the Office of the Recorder of Lake County, Indiana, described as follows: Beginning at the Southeast corner of Lot 50, in said Ellendale Farm Unit One; thence North 00 degrees 33 minutes 04 seconds West, 140.00 feet, along the East line of said Lot 50, to the Northeast corner of said Lot 50; thence North 89 degrees 26 minutes 56 seconds East, 30.00 feet along the Northerly line of said Outlot "A"; thence South 00 degrees 33 minutes 04 seconds East, 140.00 feet; thence South 89 degrees 26 minutes 56 seconds West, 30.00 feet, is the herein designated Point of Beginning.
