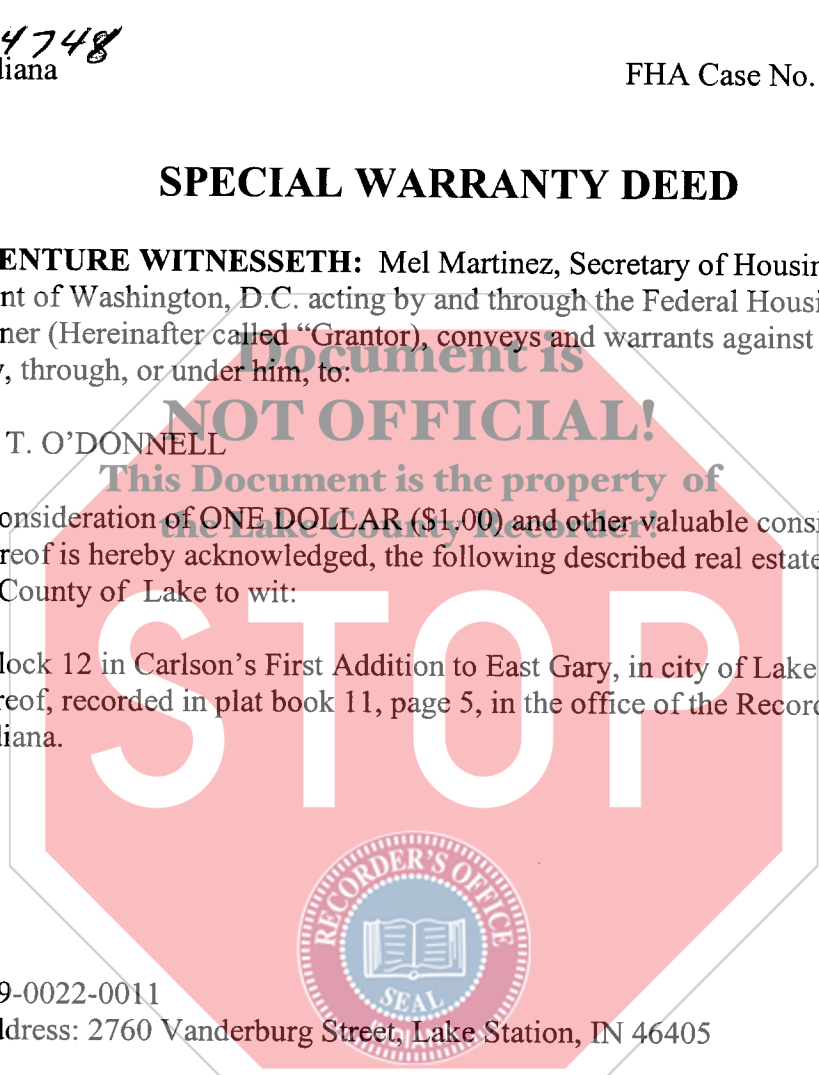
### SPECIAL WARRANTY DEED

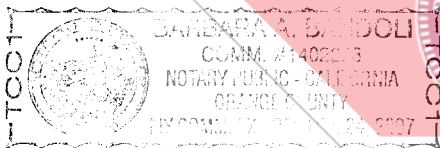
