2. Marshall E. Kirkpatrick and Beverly A. Kirkpatrick were married at the time they acquired title, as husband and wife, to the following described real estate:

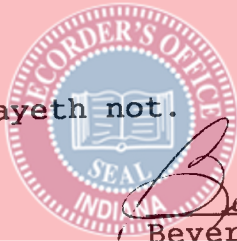

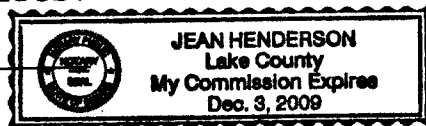
