administrators, successors and assigns, jointly and severally, firmly, by these presents.

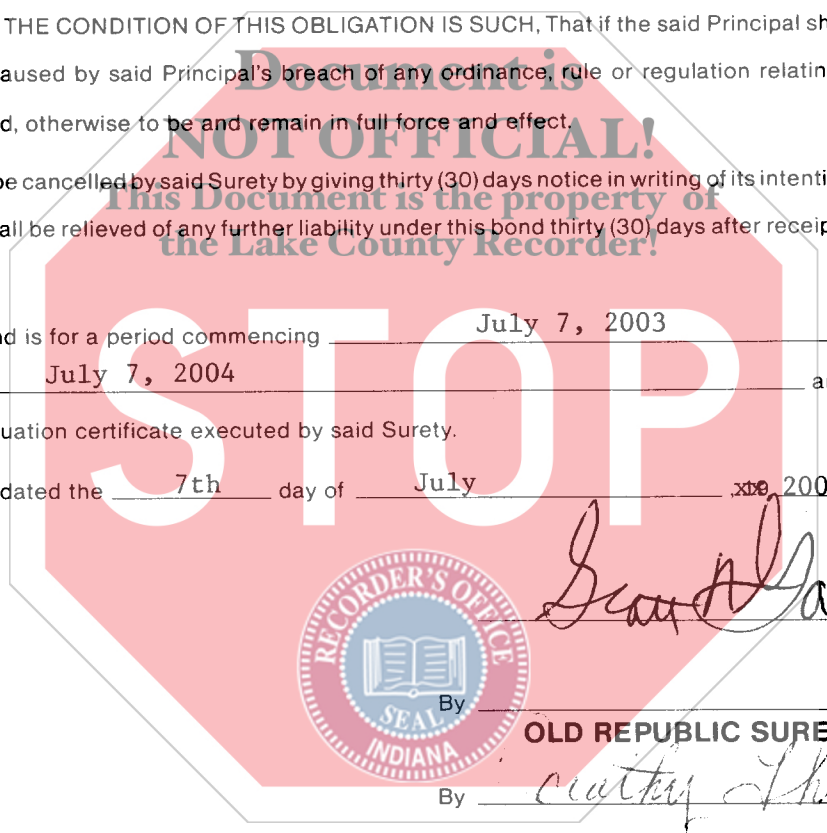
WHEREAS, the said Principal has applied to said Obligee for a license to or permit as a General Contractor
