1855 Burgundy Lane, Oak Manor Condominum, Phase II, A Horizontal Property Regime, as created by a Declaration of Condominium recorded May 8, 1974 as Document No. 250487, and amendment thereto recorded February 20, 1975 as Document No. 289219, and Second Amendment thereto recorded August 9, 1976 as Document No. 363730, and Third Amendment thereto recorded May 19, 1980 as Document No. 584906, and further amended by a restated Declaration recorded October 17, 1991 as Document No. 91052759, in the Office of the Recorder of lake County, Indiana, together with an undivided Interest in and to the common and limited areas and facilities appertaining thereto.
