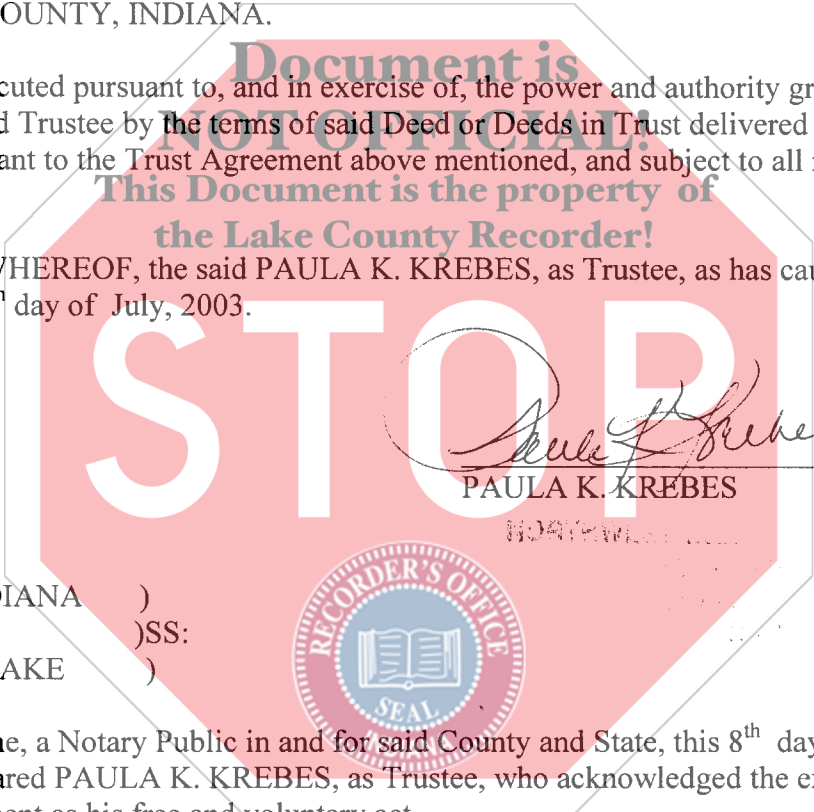
DOROTHY CLARK
