## LEGAL DESCRIPTION

Part of the West 5 rods of the East 55 rods of the Northwest Quarter of the Northeast Quarter of Section 27, Township 36 North, Range 9 West of the Second Principal Meridian, described as follows: Beginning at a point on the East line of said West 5 rods of the East 55 rods, said point being 270.0 feet North of the South line of said Northwest Quarter of the Northeast Quarter; thence North on said East line a distance of 240.0 feet to the line of 38th Street; thence West on said South line a distance of 83.40 feet to the West line of said East 55 rods; thence South on said West line, a distance of 240.22 feet to a point 269.14 feet North of the South line of said Northwest Quarter of the Northeast Quarter; thence East, a distance of 83.37 feet to the point of beginning, all in the Town of Highland, Lake County, Indiana.
