then this Obligation shall be null and void, otherwise to remain in full force and effect.

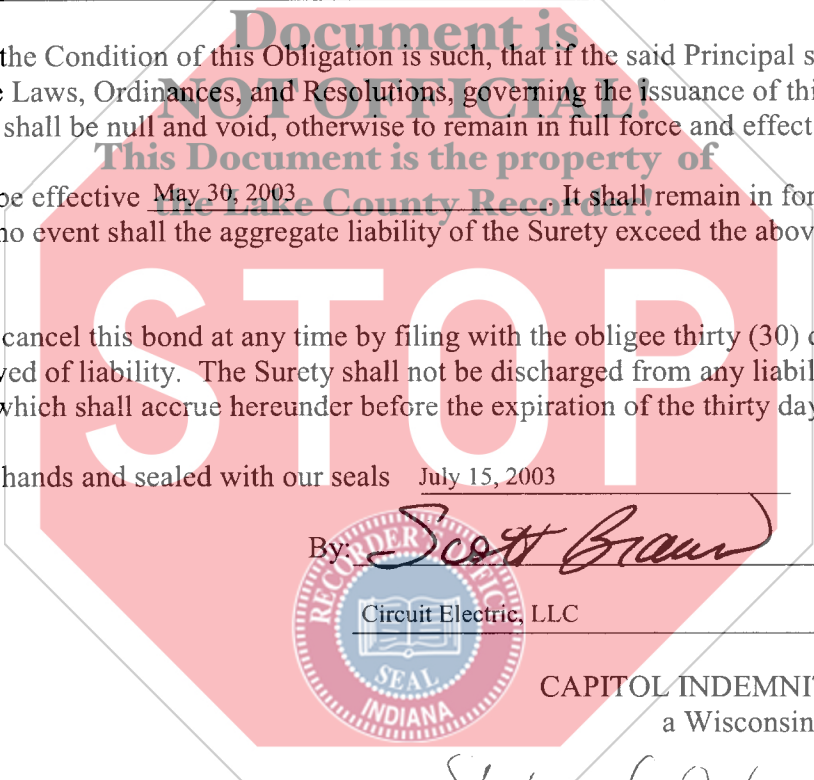
This bond shall be effective May 30, 2003 It shall remain in force until cancelled as

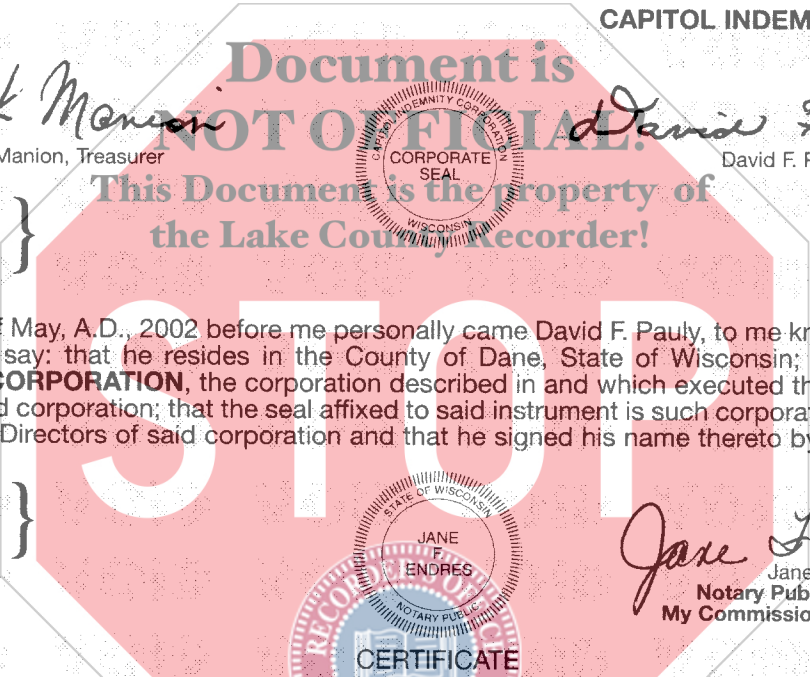
