6. That it appears that the decedents' gross probate estate, less liens and encumbrances, does not exceed the sum of the following:

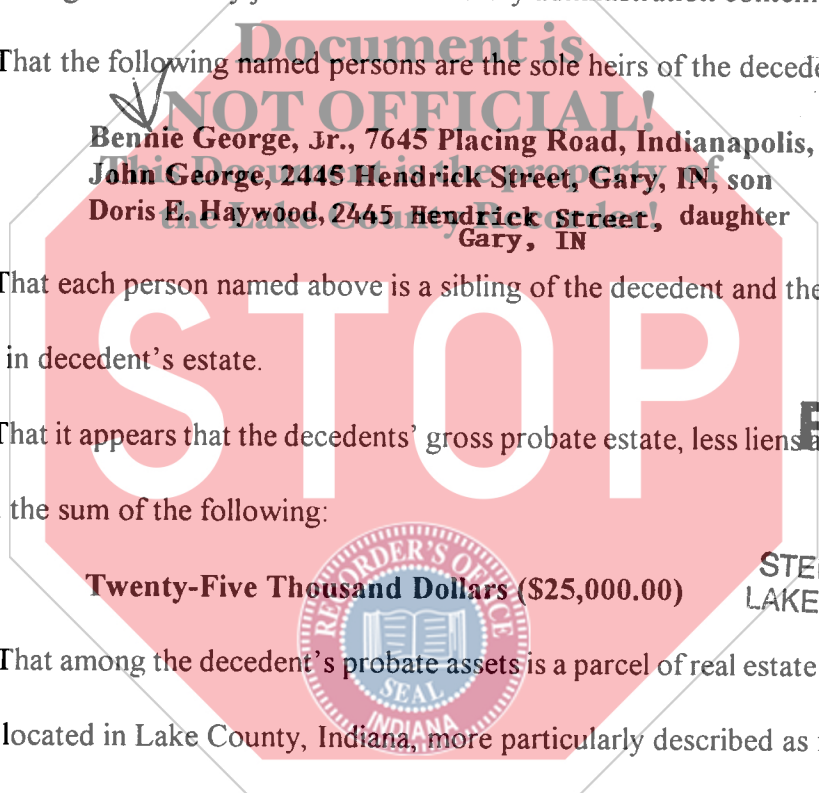
