# TAX DEED

**WHEREAS** RICHARDS, GOLDIE did the 27th day of January, 2003 produced to the undersigned, STEPHEN R. STIGLICH Auditor of the County of LAKE in the State of Indiana, a certificate of sale dated the 14th day of September, 2000, signed by PETER BENJAMIN who, at the date of sale, was Auditor of the County, from which it appears that RICHARDS, GOLDIE on the 14th day of September, 2000, purchased at public auction, held pursuant to law, the real property described in this indenture for the sum of (\$1,062.75) ONE THOUSAND, SIXTY-TWO AND 75/100 DOLLARS, being the amount due on the following tracts of land returned delinquent in the name TORRES, FRANCISCO & FERMINA for 1999 and prior years, namely:

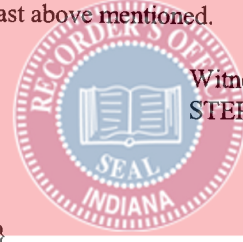
