**ORDER APPROVING PERSONAL REPRESENTATIVE'S

And it appearing that no notice or hearing on Final Account is required since all beneficiaries have waived notice and consented to the Order on Final Account without hearing, and the Court, being fully advised in the premises, now finds that:

1. No notice or hearing on Final Account is required since all beneficiaries have waived notice and consented to the Order on Final Account without hearing, and that this matter is now properly before the Court for final action thereon.

2. That **MARGUERITE MAE JACKO** died testate a resident of the County of Lake, State of Indiana, on October ~~5~~ **FILED** 5, 2002 and her Last Will and Testament was duly admitted to probate before this Court on ~~November~~ **JUN 30 2003**, 2002, and this Court appointed said

WILLIAM R. JACKO and DONALD ALAN JACKO as Co-Personal Representatives of the Last Will and Testament of the decedent, and said Co-Personal Representatives were issued Letters Testamentary on November 13, 2002, and since that date, have continued to serve in such capacity.

3. That the matters and things stated in said Accounting and Petition are true, and that said Co-Personal Representatives have accounted for all the assets in this estate coming into their hands.

4. More than three (3) months have elapsed since the date of the first published notice to legatees, devisees, and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her Co-Personal Representatives were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; and all estate taxes, inheritance taxes, and gross income taxes, if any, assessed in said estate have been paid.

5. That the following persons are the sole legatees and devisees under the decedent's Last Will and Testament: **WILLIAM R. JACKO and DONALD ALAN JACKO**. 4. Said Co-Personal Representatives having made distribution of all assets and property and having attached receipts or vouchers evidencing said distribution to said legatees and devisees, said distribution is hereby approved and confirmed.

5. Said Co-Personal Representatives are hereby released and discharged from any further liability or responsibility as Co-Personal Representatives of the Estate of **MARGUERITE MAE JACKO**.

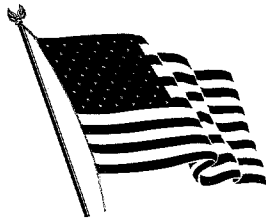
