COMPLAINT TO QUIET TITLE TO REAL ESTATE (5513 AND 5511 BEALL AVENUE, HAMMOND)

Comes now the plaintiff, by counsel, and for his complaint to quiet title to real estate, alleges and states as follows:

That plaintiff is the fee simple owner of the following real estate:

Lots 29 and 30, in Block 1, in Sohl's Second Addition to the City of Hammond, as per plat thereof, recorded in Plat Book 2 page 12, in the Office of the Recorder of Lake County, Indiana.

Commonly known as 5513 and 5511 Beall Avenue, Hammond, Indiana, and referred to herein as the "Real Estate".

2. That plaintiff's ownership of the Real Estate is based upon a duly issued Commissioner's Quit Claim Deed dated December 18, 2002, and recorded January 17, 2003, as Document No. 2003-005980, and a duly issued Commissioner's Quit Claim Deed dated December 18, 2002, and recorded January 17, 2003, as Document No. 2003-005981, in the Office of the Recorder of Lake County, Indiana. A copy of said deeds are attached hereto and marked as Exhibits "A" and Exhibit "B" (herein "Plaintiff's Deeds").

- 3. That the defendant Howard D. Gower may claim to have some right, title and interest in the Real Estate, but that all of any such right, title or interest of said defendant is inferior to that of the plaintiff.
- 4. That plaintiff asserts title to the Real Estate against the defendant, and all persons claiming by, under or through the defendant, and the purpose of this Complaint is to quiet plaintiff's title to the Real Estate.
- 5. That plaintiff has named or described all defendants in this Cause, and all persons within the knowledge of plaintiff through whom any hostile claim may be asserted against the Real Estate or plaintiff's interest therein.
- 6. That the tax title deed to the County of Lake, State of Indiana, and Plaintiff's Deeds are *prima facia* evidence of the regularity of the tax sale proceeding, the regularity of all proceedings resulting in the issuance and recording of Plaintiff's Deeds, and of valid title to the Real Estate in fee simple in plaintiff's name.
- 7. Plaintiff's Deeds vest in plaintiff an estate in fee simple absolute, free and clear of all liens and encumbrances created or suffered before the date of Plaintiff's Deeds, except the lien of the State of Indiana for taxes and special assessments which accrued subsequent to the date of Plaintiff's Deeds.

WHEREFORE, plaintiff prays that this Court enter a decree divesting the defendant, and any and all persons, corporations, heirs, lessors or assignees, claiming by, under or through the defendant of any right, title or interest in the Real Estate, quieting the title to the Real Estate in plaintiff as against the world, and vesting in plaintiff an estate in the Real Estate in fee simple absolute, free and clear of any and all liens, claims and encumbrances, by, under or through the defendant, arising prior to the date of Plaintiff's

Deeds, except the lien of the State of Indiana for property taxes and special assessments and for all other just and proper relief in the premises.
