POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

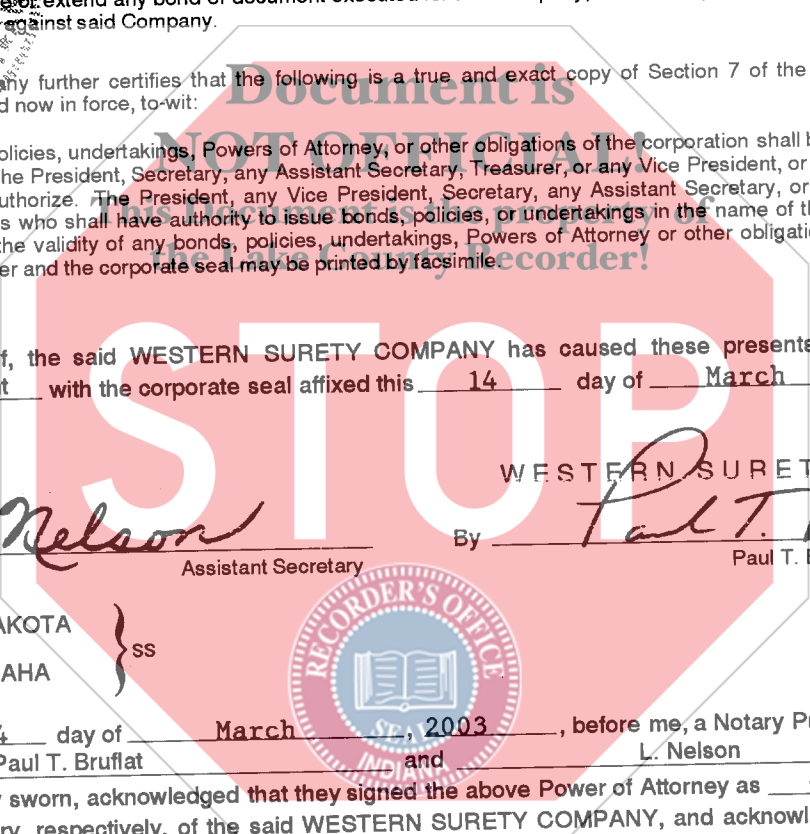
Paul T. Bruffat of Sioux Falls,
