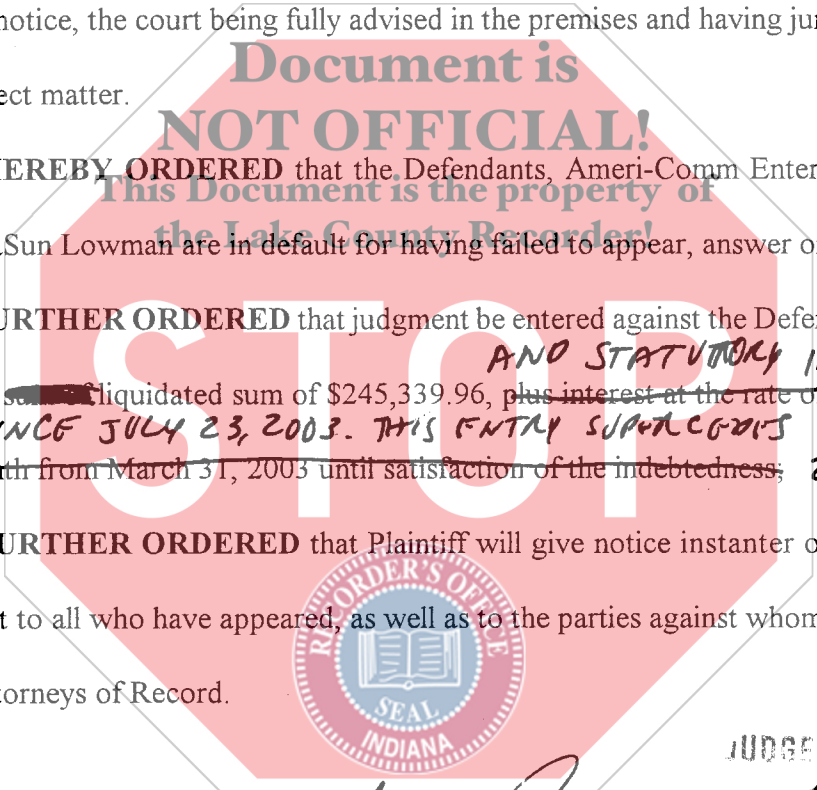
NUNC PRO TUNC ENTRY AMENDING JULY 23, 2003
