8. That this affiant widow is now the owner of the above-described real estate in fee simple by operation of probate intestate law.

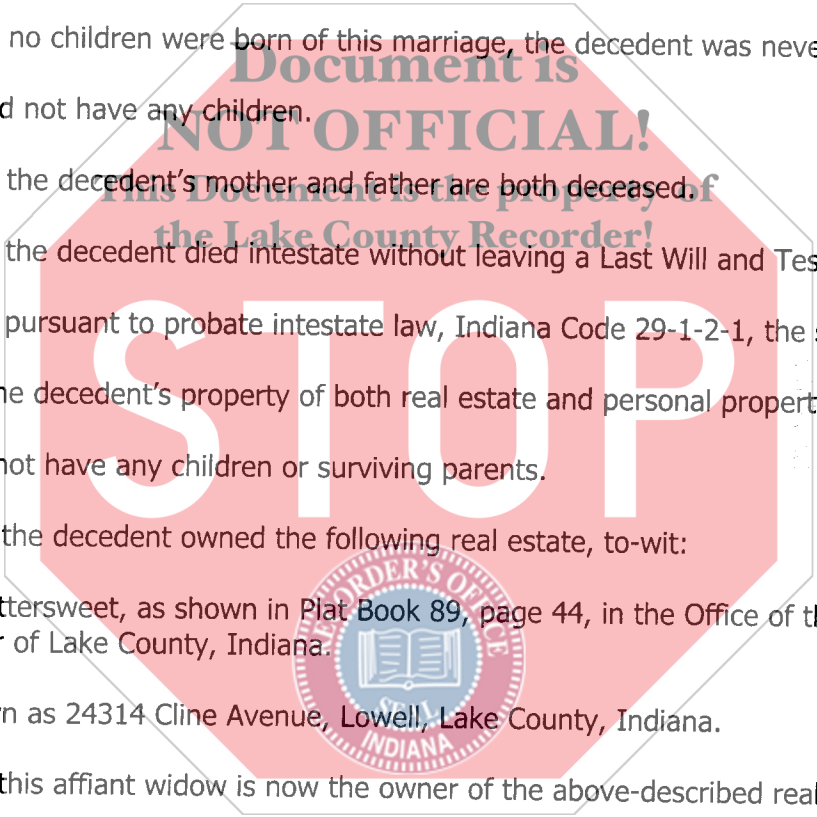
