4. That at the time of the conveyance, the corporation known as Gemini 4 Incorporated had been administratively dissolved through the Secretary of State of Indiana.

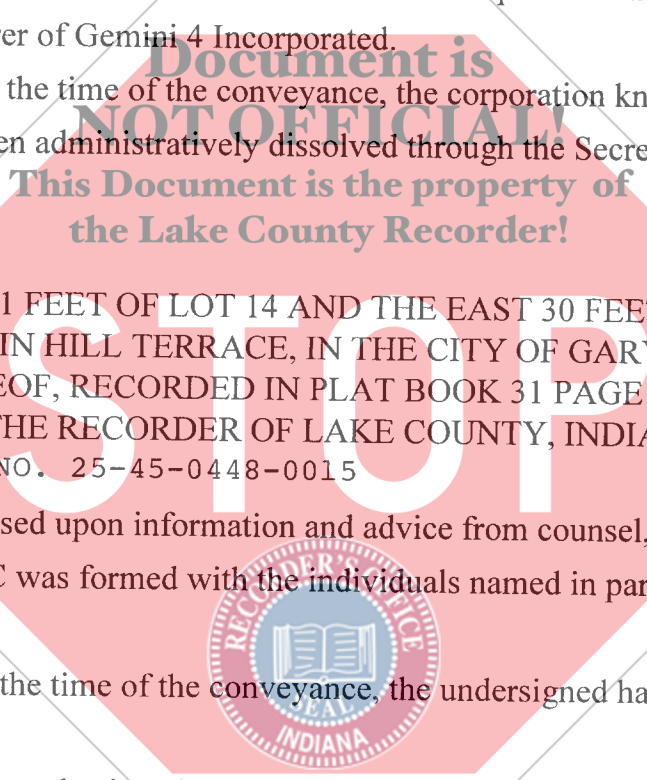
